

Dear Sir,

The Indian National Flag is a symbol of national pride for the entire nation. To further honor our flag, National Implementation Committee headed by the Hon'ble Home Minister which oversees all efforts under Azadi Ka Amrit Mahotsav has approved the programme of 'Har Ghar Tiranga'. It envisages inspiring Indians everywhere to hoist the national flag at their home. The idea behind the initiative is to invoke the feeling of patriotism in the hearts of the people and promote awareness about our national flag.

2. On 20<sup>th</sup> May 2022, Cabinet Secretary chaired a meeting of 'Committee of Secretaries'(COS) with all Chief Secretaries on "Har Ghar Tiranga" and outlined following tasks to be undertaken to ensure successful implementation of the program: -

- i. Active participation of all employees of State government, State PSUs, self-help groups, civil society organizations etc. and their families under your administrative jurisdiction.
- ii. Corporate and private organizations may also be encouraged to participate and contribute including CSR resources.
- iii. Creating buzz/awareness building by utilizing websites & social media handles of State government. All State government websites to carry banners linking to Amrit Mahotsav Website - Har Ghar Tiranga corner (amritmahotsav.nic.in).
- iv. Outreach sessions with heads of panchayats at the level of concerned departments.
- v. Identification of flag distribution and sales point in each village.
- vi. Self-help groups to be leveraged for stitching of flags, supported by local tailoring groups.
- vii. Enmass purchase of flags to be encouraged by panchayats.
- viii. All government buildings and institutions to hoist the flag.
- ix. Communication material via pamphlets, standees, banners etc to be displayed prominently in local language(s).
- x. Vast network of fair price shops to be leveraged as distribution/ sales point for the flags.
- xi. State transport buses to be painted with messages about Har Ghar Tiranga.
- xii. Toll and check points to be branded, utilized for pamphlets & leaflets.

Dear Sir,

This letter is in continuation to my DO letter No. 42-22/119/2022-AKAM dated 23<sup>rd</sup> May 2022 wherein details about "Har Ghar Tiranga" were conveyed.

2. On 2<sup>nd</sup> June 2022, Group of Ministers consisting of Hon'ble Minister of Textiles, Commerce and Industry, Consumer Affairs, Food & Public Distribution, Hon'ble Minister of Culture, Tourism & Development of North Eastern Region and Hon'ble Minister of Information & Broadcasting and Youth Affairs & Sports chaired a meeting to review preparedness of "Har Ghar Tiranga" and outlined following tasks to be undertaken to ensure successful implementation of the program.

- i. Panchayati Raj Department in all States/ UTs to be designated as Nodal entities for stocking and distribution of flags.
- ii. District Collectors to be suitably instructed to constantly monitor progress of implementation program.
- iii. Post offices, Panchayats, Common Service Centers to be utilized for distribution of flags.
- iv. Gram Sabhas may be used to ascertain demand of flags through Gram Pradhans.

**Subject: Partition Horrors Remembrance Day**

Respected Madam/Sir,

As you are aware that Hon'ble Prime Minister in his speech on 15<sup>th</sup> August, 2021 had announced to observe 14<sup>th</sup> of August as '*Partition Horrors Remembrance Day*'. In this year of Azadi Ka Amrit Mahotsav (AKAM), when the nation completes 75 years of independence, the Partition Horrors Remembrance Day is being observed throughout the country.

The Partition Horrors Remembrance Day has been envisaged to bring to light the agony, suffering and pain of millions of people who were the sufferers of partition. It is to remind the country of the largest displacement of human population in the last century, which also claimed the lives of a large number of people.

To showcase the sufferings of the partition affected people, an exhibition has been curated jointly by the Indian Council of Historical Research (ICHR) and Indira Gandhi National Centre for the Arts (IGNCA). This exhibition, in English and Hindi, is available in digital format at the website address <https://amritmahotsav.nic.in/partition-horror-remembrance-day.htm>

All the universities and their affiliated/constituent colleges/ institutions are requested to display the exhibition during 10<sup>th</sup> to 14<sup>th</sup> August, 2022 at prominent places, where a large number of people can see it. Realizing the sensitivity of the issue, it should be ensured that the exhibition is showcased with the sobriety and solemnness that it deserves. It should be especially ensured that the sentiments of any section of society are not allowed to be hurt. The display of exhibition may be accompanied with small programmes to be organized by the head of the relevant institution. A Standard Operating Procedure (SOP) for organizing these programmes is also attached (**Annexure-I**), which may be followed in all cases.

14 AUGUST 2022

### Important Instructions for the Exhibition

1. This exhibition should be displayed at the important public places like banks, post offices, Govt buildings, educational institutions, community halls, petrol pumps, shopping malls etc. Enough efforts should be made so that that maximum people can see the exhibition
2. This exhibition can be printed on sun-board and be placed on easels  
The size can be 2.5' x 4'
3. This exhibition can also be shown through digital media
4. There can be a brief function at the beginning of the exhibition
5. Freedom Fighters, prominent senior citizens or public representatives be requested to inaugurate this exhibition
6. Patriotic songs be played during the inaugural ceremony
7. In the beginning there can be a brief introduction about the purpose of the exhibition
8. Media be invited to the exhibition
9. Persons who have suffered the tragedy of partition should be invited to the exhibition
10. The inaugural ceremony should end with the National Anthem
11. Exhibition should be displayed for a definite duration
12. Enough arrangements be made for security of the exhibition
13. Enough efforts be made so that more and more people can come and see the exhibition
14. The exhibition is organised to remember the tragedy and agony of the partition so the sensitivity of this exhibition be remembered. It should also be ensured that no section of the society gets hurts by any act during the exhibition.
